

## **IDRS Honorary Membership, 2002 Guidelines for Selecting Honorary Members**

(as approved by the Executive Committee of IDRS, January, 2002)

1. Members wishing to nominate an individual for Honorary Membership in IDRS must direct nominations, with a short biographical sketch of the candidate, to any member of the Honorary Membership Nomination Committee. Members of this committee may also nominate candidates.
2. A candidate for Honorary Membership will have completed meritorious service to the Society and/or area of double reed performance, teaching, instrument making, repair, reedmaking, etc. The candidate must be retired from his/her primary position.
3. Nominations may not be made posthumously.
4. All nomination materials and procedures will be kept strictly confidential.
5. The Nominating Committee is encouraged to nominate no more than two candidates per year. The slate of nominees may be expanded under special circumstances. The Executive Committee will vote on each of the nominees and has the authority of final approval.
